After careful review of your security profile, we are pleased to inform you that you have completed your Supply Chain Security Profile commitment and we welcome you as a certified member of the C-TPAT/FAST programs. Customs and Border Protection will proceed to provide Landstar Gemini, Inc.

with C-TPAT/FAST benefits including a reduced level of cargo exams, anti-terrorism training seminars, sharing of information and best practices, etc.



Also, as part of your ongoing C-TPAT/FAST commitment, a self-policing program should be developed in order to review security procedures on a regular basis. Please see the attached document with regards to self-policing. U.S. Customs and Border Protection will soon provide all partners with a C-TPAT/FAST yearly assessment to be completed by the appropriate company officials.

Again, I welcome you as a C-TPAT/FAST partner and I thank you in advance for your support in this important effort.

Enclosed you will find a co-signed copy of the C-TPAT/FAST agreement and a consent form, to be signed at your discretion, granting Customs and Border Protection permission to mention your company's name during public events dealing with trade security issues.
